Executive Summary

This document contains the a list of trusted Credential Service Providers developed by the E-Authentication Program Management Office (PMO). Inclusion on this list is a result of the PMO's conduct of uniform assessments of Credential Service Providers (CSP) for use by agency applications commensurate with the levels of trust identified by their individual risk assessments, as detailed in the companion document, the E-Authentication Credential Assessment Framework. The specific criteria used in the assessment process are expressed in Credential Assessment Profiles (CAPs) included in the CAF Document suite.

The E-Authentication PMO maintains this list, which contains the Credential Services (CSs) that can be used by the initiative. The assessment process is governed by assessment profiles, which establish the requirements for CSs at the four E-Authentication Assurance Levels. The assessment produces a recommended Assurance Level to the E-Authentication PMO, which makes the final decisions on additions to the Trust List. All additions to the trust list must be preceded by a credential assessment, and approved by the E-Authentication Program Executive.
